While Menorah celebrates 40 years, the Menorah board is planning for the next 40 years, and we couldn't do it without your support. On behalf of the entire board, thank you for your interest, time, commitment, and financial support of this fabulous organization that not only provides care for our aging population, but the ability for families to focus on the quality time they have with their loved ones.


In partnership with The Cathedral of St. Jude the Apostle, the Spiritual Care Department began hosting Catholic worship services – a monthly Mass and a monthly Eucharistic Service with Rosary prayers in addition to the weekly Eucharistic minister visits.





Menorah Life partnered with the Tampa Bay International School to provide intergenerational programming for Samson Nursing Center and Toby Weinman residents including a student-led Hanukkah performance and Purim carnival hosted by the residents.

In partnership with Empath Health, the Spiritual Care Department sponsored an inaugural Reiki staff training for nurses and CNAs. Menorah Life is the first senior community in Pinellas County to offer a Reiki training program to enhance the lives of residents, families and staff.

Menorah Life's Samson Nursing Center in St. Petersburg has been honored with the 2024 Bronze Commitment to Quality Award by the American Health Care Association and National Center for Assisted Living (AHCA/NCAL). 




